

## LIMITED WARRANTY

SOS CORPORATION (SOS) warrants to the present OWNER that

a) if this is a new installation, that it will be free from defects in operation of the garage door(s) resulting from improper or defective workmanship in the installation thereof for a period of two (2) years from the date that the installation is completed.

b) if this is a repair or alteration of an existing installation, that it will be free from defects in operation resulting from improper or defective workmanship in performing the repair or alteration for a period of one (1) year from the date of the completion of the repair or alteration work.

If, during the applicable Limited Warranty Period as provided above, it appears that there is a defect in workmanship which is covered by this Limited Warranty, SOS shall make such repairs or replacements that it, in its sole discretion, deems necessary to correct the defective condition.

SOS will make repairs during normal service hours, which are Monday through Friday, 9:00 a.m. to 6:00p.m. In the event that OWNER requests warranty service on Saturday, Sunday or after 6:00 p.m. on weekdays, SOS will charge OWNER its regular service call rates then in effect, which will be quoted to OWNER in advance.

**THIS WARRANTY IS IN LIEU OF ANY OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTY OF MERCHANT ABILITY OR FITNESS FOR A PARTICULAR PURPOSE, OR OTHERWISE, AND OF ANY OTHER OBLIGATIONS OR LIABILITY ON THE PART OF SOS CORPORATION. THIS LIMITED WARRANTY DOES NOT COVER NON-DEFECT DAMAGE CAUSED BY OWNER'S NEGLIGENCE, IMPROPER OPERATION OR CARE (INCLUDING BUT NOT LIMITED TO ABUSE, MISUSE, FAILURE TO PROVIDE REASONABLE AND NECESSARY MAINTENANCE) ALTERATIONS MADE BY OWNER, VANDALISM, DAMAGE CAUSED BY INSECT INFESTATION, OR DETERIORATION OR DAMAGE CAUSED BY SEVERE WEATHER CONDITIONS. IN NO EVENT SHALL THE MAXIMUM LIABILITY HEREUNDER EXCEED THE REPLACEMENT COST OF THE UNIT.**

**THIS WARRANTY EXTENDS ONLY TO THE OWNER AT THE TIME OF COMPLETION, AND IS NOT TRANSFERABLE.**

**UNDER NO CIRCUMSTANCES SHALL SOS BE LIABLE FOR CONSEQUENTIAL, INDIRECT, INCIDENTAL OR SPECIAL DAMAGES ARISING IN CONNECTION WITH THE USE, OR INABILITY TO USE THE INSTALLATION. IN NO EVENT SHALL SOS' LIABILITY FOR BREACH OF WARRANTY, BREACH OF CONTRACT, NEGLIGENCE OR STRICT LIABILITY EXCEED THE COST OF THE INSTALLATION COVERED HEREBY. NO PERSON OR ENTITY IS AUTHORIZED TO ASSUME ON BEHALF OF SOS ANY OTHER LIABILITY IN CONNECTION WITH THE INSTALLATION.**

## RIGHT TO CANCEL

If this invoice relates to a new installation, you have a right to cancel this Agreement within three (3) days of the date hereof, (or within three (3) days of the date of initial deposit, whichever is later) and receive a full refund of your deposit.
